The Role:

Major Responsibilities:

 requirements.
- Financial oversight of all medical services activities including the LH&WC, and the key strategic partners engaged at activities within our Clinic network.
- Analyse financial performance related to strategic partnerships, including revenue, expenses, and profit margins. This includes an in-depth financial analysis to monitor profitability, costs, revenue streams, accounts receivable and payable and key performance indicators (KPIs) for each clinic.
- Prepare monthly, quarterly, and annual financial reports detailing the company's share
 of profits from each partnership, including variance analysis.

- Ensure accurate budgeting, forecasting and financial reporting including any profit share and rebate agreements.
- Oversee LH&WC lease management activities including governance and financial reporting.
- Conduct financial modelling and scenario analysis to evaluate the impact of strategic partnerships on overall company profitability.
- Conduct regular financial reviews and audits with strategic partners to verify the accuracy of financial reporting, ensuring adherence to profit-sharing agreements.
- Measure, monitor and report medical services investments including LH&WC and demonstrate portfolio ROI.
- Lead financial due diligence for medical services as required, including assessing risks, financial projections, and strategic fit. Evaluate potential investments, expansions, and new business opportunities, providing financial models and ROI analyses to support decision-making.
- Develop dashboards and financial KPIs to monitor the performance of strategic partnerships and ensure KPI's are met.

- Provide analytical and commercial support to our Pricing & Product Development,
 Claims Management and Senior Management making innovative suggestions for products and services that promotes our brand and our business.
